Section 1 will be implemented on the territory of the commune of Słubice, in the district of Słubice, and it covers the right bank of the Odra from 581.0 km to 585.7 km.

Section 2 will be implemented in the commune of Górzyca, in the district of Słubice, covering the right bank of the Odra from 604.0 km to 605.0 km.

Section 3 will be implemented in the commune of Kostrzyn nad Odrą, in the district of Gorzów, covering the right bank of the Odra from 613.5 km to 614,7 km,

Section 6b will be implemented on the territory of the commune of Kostrzyn nad Odrą, in the district of Gorzów, covering the right bank of the Odra from 613.1 to 613.5 km.
